Prior to and during the course of the inspection, including, but not limited to, on September 22, 2020, the employer did not establish and implement a system for communicating wildfire smoke hazards including provisions designed to encourage employees to inform the employer of wildfire smoke hazards at the worksite without fear of reprisal. During widespread wildfires, no system was in place for informing employees of the current AQI and the protective measures available to reduce their wildfire smoke exposures, nor were there any procedures for encouraging employees to report worsening air quality or any adverse symptoms resulting from wildfire smoke.
