ORDER OF SUSPENSION

WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider if the individual has been convicted of any felony or misdemeanor described in Labor Code section 139.21(a)(1)(A); and

WHEREAS, on or about December 6, 2018, Respondent Arman Abovyan pled guilty to or was found guilty of one or more felonies or misdemeanors described in Labor Code section 139.21(a)(1)(A) in the United States District Court, Southern District of Florida; and

WHEREAS, Labor Code section 139.21(a)(1)(B) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider who has been suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Arman Abovyan was suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification, or approval to provide health care services has been surrendered or revoked; and

WHEREAS, on or about September 11, 2020, Arman Abovyan's license, certification, or approval to provide health care services was surrendered or revoked by the California Medical Board, Department of Consumer Affairs; and

1 WHEREAS, on or about February 15, 2023, the Administrative Director mailed to Arman
2 Abovyan a written notice of the right to a hearing regarding the suspension and the procedure
3 to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California
4 Code of Regulations, title 8, section 9788.1; and

5 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of
6 Regulations, title 8, section 9788.1(d), the written notice advised Arman Abovyan that the
7 suspension would start thirty (30) calendar days after the date of mailing of written notice,
8 unless Arman Abovyan submitted a written request for a hearing within ten (10) calendar days
9 of the date of mailing of the notice; and

10 WHEREAS, Arman Abovyan did not submit a written request for hearing within ten (10)
11 calendar days of the date of mailing of the notice; and

12 WHEREAS, the Administrative Director is required to suspend any physician,
13 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of
14 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was mailed,
15 unless the physician, practitioner, or provider submits a written request for a hearing within ten
16 (10) calendar days of the date of mailing of the notice;

17 **IT IS HEREBY ORDERED** that Arman Abovyan is hereby suspended from participating
18 in the workers' compensation system as a physician, practitioner, or provider.
