**ORDER OF SUSPENSION**

WHEREAS, Labor Code section 139.21(a)(1)(B) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider who has been suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Respondent Robert William Anderson, Jr., was suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification, or approval to provide health care services has been surrendered or revoked; and

WHEREAS, on or about July 13, 2018, Robert William Anderson, Jr.'s license, certification, or approval to provide health care services was surrendered or revoked by the Board of Registered Nursing, Department of Consumer Affairs; and

WHEREAS, on or about December 19, 2023, the Administrative Director mailed to Robert William Anderson, Jr., a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

1           WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of  
2 Regulations, title 8, section 9788.1(d), the written notice advised Robert William Anderson,  
3 Jr., that the suspension would start thirty (30) calendar days after the date of mailing of  
4 written notice, unless Robert William Anderson, Jr., submitted a written request for a  
5 hearing within ten (10) calendar days of the date of mailing of the notice; and

6           WHEREAS, Robert William Anderson, Jr., did not submit a written request for  
7 hearing within ten (10) calendar days of the date of mailing of the notice; and

8           WHEREAS, the Administrative Director is required to suspend any physician,  
9 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of  
10 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was  
11 mailed, unless the physician, practitioner, or provider submits a written request for a  
12 hearing within ten (10) calendar days of the date of mail of the notice;

13           **IT IS HEREBY ORDERED** that Respondent Robert William Anderson, Jr., is hereby  
14 suspended from participating in the workers' compensation system as a physician,  
15 practitioner, or provider.
