10                                   **ORDER OF SUSPENSION**

11                                 WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to  
12 suspend any physician, practitioner, or provider from participating in the workers'  
13 compensation system as a physician, practitioner, or provider whose license, certification or  
14 approval to provide health care services has been surrendered or revoked; and

15                                 WHEREAS, on or about November 23, 2016, Lisa Maffei's license, certification or  
16 approval to provide health care services was surrendered or revoked by the California Board of  
17 Register Nursing, Department of Consumer Affairs; and

18                                 WHEREAS, on or about December 2, 2019, the Administrative Director mailed to Lisa  
19 Maffei a written notice of the right to a hearing regarding the suspension and the procedure to  
20 follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California  
21 Code of Regulations, title 8, section 9788.1; and

22                                 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of  
23 Regulations, title 8, section 9788.1(d), the written notice advised Lisa Maffei that the  
24 suspension would start thirty (30) calendar days after the date of mailing of written notice,  
25 unless Lisa Maffei submitted a written request for a hearing within ten (10) calendar days of  
26 the date of mailing of the notice; and

27                                 WHEREAS, Lisa Maffei did not submit a written request for hearing within ten (10)  
28 calendar days of the date of mailing of the notice; and

                                  WHEREAS, the Administrative Director is required to suspend any physician,  
practitioner, or provider pursuant to Labor Code section 139.21 and title 8, California Code of

1 Regulations section 9788.2, after thirty (30) days from the date the notice was mailed, unless  
2 the physician, practitioner, or provider submits a written request for a hearing within ten (10)  
3 calendar days of the date of mailing of the notice;

4 **IT IS HEREBY ORDERED** that Lisa Maffei is hereby suspended from participating in  
5 the workers' compensation system as a physician, practitioner, or provider.
