Labor Code section 139.21(a)(1)(A) requires the Administrative Director of the Division of Workers' Compensation (Administrative Director) to suspend any physician, practitioner, or provider from participating in the California workers' compensation system as a physician, practitioner, or provider if the individual or entity has been convicted of any felony or misdemeanor and that crime either: (1) involves fraud or abuse of the federal Medicare or Medicaid programs, the Medi-Cal program, or the workers' compensation system, or fraud or abuse of any patient; (2) relates to the conduct of the individual's medical practice as it pertains to patient care; or (3) is a financial crime that relates to the federal Medicare or Medicaid programs, the Medi-Cal program, or the workers' compensation system.

Labor Code section 139.21(a)(1)(B) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the California workers' compensation system as a physician, practitioner, or provider if the individual or entity has been suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs or the Medi-Cal program.

Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the California workers' compensation system as a physician, practitioner, or provider whose license, certification or approval to provide health care services has been surrendered or revoked.

1 On or about December 4, 2017, Respondent Felipe Najjar Perez (Perez) was
2 convicted in the Superior Court of California, County of Riverside, of crimes described in
3 Labor Code section 139.21(a)(1)(A). (People v. Felipe Najjar Perez, Case No
4 RIF1702576.)

5 On or about October 11, 2017, Respondent Perez was suspended, due to fraud
6 or abuse, from the federal Medicare or Medicaid programs.

7 On or about May 23, 2018, Respondent Perez's license, certification or approval
8 to provide health care services was surrendered or revoked by the Respiratory Care
9 Board of California, Department of Consumer Affairs.

10 On or about August 12, 2022, the Administrative Director mailed to Respondent
11 Perez a written notice of the right to a hearing regarding the suspension and the
12 procedure to follow to request a hearing, as provided in Labor Code section
13 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1.

14 Pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations,
15 title 8, section 9788.1(d), the written notice advised Respondent Perez that the
16 suspension would start thirty (30) calendar days after the date of mailing of written
17 notice, unless Respondent Perez submitted a written request for a hearing within ten
18 (10) calendar days of the date of mailing of the notice.

19 Respondent Perez did not submit a written request for hearing within ten (10)
20 calendar days of the date of mailing of the notice.

21 The Administrative Director is required to suspend any physician, practitioner, or
22 provider pursuant to Labor Code section 139.21 and California Code of Regulations,
23 title 8, section 9788.2, after thirty (30) days from the date the notice was mailed, unless
24 the physician, practitioner, or provider submits a written request for a hearing within ten
25 (10) calendar days of the date of mailing of the notice;
