Labor Code section 139.21(a)(1)(A) requires the Administrative Director of the Division of Workers' Compensation (Administrative Director) to suspend any physician, practitioner, or provider from participating in the California workers' compensation system as a physician, practitioner, or provider if the individual or entity has been convicted of any felony or misdemeanor and that crime either: (1) involves fraud or abuse of the federal Medicare or Medicaid programs, the Medi-Cal program, or the workers' compensation system, or fraud or abuse of any patient; (2) relates to the conduct of the individual's medical practice as it pertains to patient care; or (3) is a financial crime that relates to the federal Medicare or Medicaid programs, the Medi-Cal program, or the workers' compensation system.

Labor Code section 139.21(a)(1)(B) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the California workers' compensation system as a physician, practitioner, or provider if the individual or entity has been suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs or the Medi-Cal program.

Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the California workers' compensation system as a physician, practitioner, or provider whose license, certification or approval to provide health care services has been surrendered or revoked.

1 On or about August 7, 2017, Respondent Rosanne Cecilia State (State) was  
2 convicted in the Superior Court of California, County of Riverside, of crimes described in  
3 Labor Code section 139.21(a)(1)(A). (People v. State, Case No. M188608.)

4 On or about March 1, 2016, Respondent State was suspended, due to fraud or  
5 abuse, from the federal Medicare or Medicaid programs.

6 On or about, May 17, 2017, Respondent State's license, certification or approval  
7 to provide health care services was surrendered or revoked by the Medical Board of  
8 California, Department of Consumer Affairs.

9 On or about June 7, 2022, the Administrative Director mailed to Respondent  
10 State a written notice of the right to a hearing regarding the suspension and the  
11 procedure to follow to request a hearing, as provided in Labor Code section  
12 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1.

13 Pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations,  
14 title 8, section 9788.1(d), the written notice advised Respondent State that the  
15 suspension would start thirty (30) calendar days after the date of mailing of written  
16 notice, unless Respondent State submitted a written request for a hearing within ten  
17 (10) calendar days of the date of mailing of the notice.

18 Respondent State did not submit a written request for hearing within ten (10)  
19 calendar days of the date of mailing of the notice.

20 The Administrative Director is required to suspend any physician, practitioner, or  
21 provider pursuant to Labor Code section 139.21 and California Code of Regulations,  
22 title 8, section 9788.2, after thirty (30) days from the date the notice was mailed, unless  
23 the physician, practitioner, or provider submits a written request for a hearing within ten  
24 (10) calendar days of the date of mailing of the notice;
