ORDER OF SUSPENSION

Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the California workers' compensation system as a physician, practitioner, or provider whose license, certification, or approval to provide health care services has been surrendered or revoked.

On or about November 30, 2022, Respondent Amy Dinh Todd's (Todd) license, certification, or approval to provide health care services was surrendered or revoked by the Board of Pharmacy, Department of Consumer Affairs, State of California.

On or about July 24, 2023, the Administrative Director mailed to Respondent Todd a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1.

Pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Respondent Todd that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Respondent Todd submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the notice.

By letter dated July 29, 2023, Respondent Todd timely requested a hearing to appeal her suspension under Labor Code section 139.21(a)(1)(C). The Administrative Director, by Notice of Hearing and Designation of Hearing Officer dated August 16,

1 2023, scheduled a hearing on the suspension for August 31, 2023. At the scheduled
2 hearing, Respondent Todd withdrew her appeal of the suspension.

3 The Administrative Director is required to suspend any physician, practitioner, or
4 provider pursuant to Labor Code section 139.21 and California Code of Regulations,
5 title 8, section 9788.2, after thirty (30) days from the date the notice was mailed, unless
6 the physician, practitioner, or provider submits a written request for a hearing within ten
7 (10) calendar days of the date of mailing of the notice. As Respondent Todd has
8 withdrawn her request for a hearing,

9 **IT IS HEREBY ORDERED** that Respondent Amy Dinh Todd is hereby
10 suspended from participating in the California workers' compensation system as a
11 physician, practitioner, or provider.
