PREDETERMINED INCREASE FOR
CARPENTER (SD-23-31-4-2006-1)
CARPENTER (ENGINEERING CONSTRUCTION)
IN SAN DIEGO COUNTY

This predetermined increase for the above named craft applies only to the current determination for work being performed on public works projects with bid advertisement dates on or after **September 1, 2006**, until this determination is superseded by a new determination or a predetermined increase modification notice becomes effective.

When referencing our prevailing wage determinations, please note that if the prevailing wage rate determination which was in effect on the bid advertisement date of a project has a single asterisk (*) after the expiration date, the rate will be good for the life of the project. However, if a prevailing wage rate determination has double asterisks (**) after the expiration date, the rate must be updated on the following date to reflect the predetermined rate change(s).

CARPENTER: Engineering Construction (except Light Commercial)

Determination SD-23-31-4-2006-1 is currently in effect and expires on December 31, 2006**.

Effective on January 1, 2007, there will be an increase of \$0.25 to be allocated to Pension.

Effective on July 1, 2007, there will be an increase of \$2.25 to be allocated as follows: \$1.90 to Basic Hourly Wage, \$0.25 to Pension, and \$0.10 to Vacation and Holiday (Supplemental Dues).

Effective on July 1, 2008, there will be an increase of \$2.25 to be allocated as follows: \$1.84 to Basic Hourly Wage, \$0.30 to Pension, \$0.09 to Vacation and Holiday, and \$0.02 to Training.

Effective on July 1, 2009, there will be an increase of \$1.00 to be allocated to Pension. (*See modification notice dated June 29, 2009*)

Effective on July 1, 2010, there will be an increase of \$0.50 to be allocated to Pension. (*See modification notice dated June 2, 2010*)

Effective on July 1, 2011, there will be an increase of \$0.75 to be allocated to wages and/or fringe benefits.

There will be no further increases applicable to this determination.

CARPENTER: Light Commercial *(see modification notice dated June 20, 2007)*

Effective on July 1, 2007, there will be an increase of \$1.87 to be allocated as follows: \$1.52 to Basic Hourly Rate, \$0.25 to Pension, and \$0.10 to Vacation/Holiday (Supplemental Dues)

Effective on July 1, 2008, there will be an increase of \$1.80 to be allocated to wages and/or fringe benefits.

Effective on July 1, 2009, there will be an increase of \$1.80 to be allocated to wages and/or fringe benefits.

There will be no further increases applicable to this determination.
