IN ALL LOCALITIES WITHIN ALAMEDA, ALPINE, AMADOR, BUTTE, CALAVERAS, COLUSA, CONTRA COSTA, DEL NORTE, EL DORADO, FRESNO, GLENN, HUMBOLDT, KINGS, LAKE, LASSEN, MADERA, MARIN, MARIPOSA, MENDOCINO, MERCED, MODOC, MONTEREY, NAPA, NEVADA, PLACER, PLUMAS, SACRAMENTO, SAN BENITO, SAN FRANCISCO, SAN JOAQUIN, SAN MATEO, SANTA CLARA, SANTA CRUZ, SHASTA, SIERRA, SISKIYOU, SOLANO, SONOMA, STANISLAUS, SUTTER, TEHAMA, TRINITY, TULARE, TUOLUMNE, YOLO & YUBA COUNTIES.

This predetermined increase for the above named craft applies only to the current determination for work being performed on public works projects with bid advertisement dates on or after **September 1, 2008**, until this determination is superseded by a new determination or a predetermined increase modification notice becomes effective.

When referencing our prevailing wage determinations, please note that if the prevailing wage rate determination, which was in effect on the bid advertisement date of a project, has a single asterisk (*) after the expiration date, the rate will be good for the life of the project. However, if a prevailing wage rate determination has double asterisks (**) after the expiration date, the rate must be updated on the following date to reflect the predetermined rate change(s).

DRYWALL INSTALLER/LATHER (CARPENTER) (All Areas):

Determination NC-31-X-16-2008-2 is currently in effect and expires on December 31, 2008**.

Effective January 1, 2009, there will be an increase of \$0.45 to Basic Hourly Rate **for Area 3 only**.

Effective July 1, 2009, there will be the following increases:

- \$0.50 to Health and Welfare
- \$0.55 to Pension (includes \$0.05 to Annuity)
- \$0.13 to Vacation (includes \$0.08 to Work Fee)
- \$0.05 to Training

Effective August 1, 2009, there will be an increase of \$1.75 to Basic Hourly Rate

Effective January 1, 2010, there will be an increase of \$0.45 to Basic Hourly Rate **for Area 3 only**.

Effective July 1, 2010, there will be the following increases:

- \$0.50 to Health and Welfare
- \$0.60 to Pension (includes \$0.10 to Annuity)
- \$0.18 to Vacation (includes \$0.08 to Work Fee)
- \$0.05 to Training

Effective August 1, 2010, there will be an increase of \$1.00 to Basic Hourly Rate and \$.85 to Pension

Effective January 1, 2011, there will be an increase of \$0.45 to Basic Hourly Rate **for Area 3 only**.

Effective July 1, 2011, the \$1.28 increase has been rescinded. (*See Important Notice dated June 30, 2011*)

Effective August 1, 2011, there will be the following increases (*See Important Notice dated June 30, 2011*):

- \$1.50 to Pension
- \$0.05 to Training
- \$0.11 to Health & Welfare
- \$0.02 to Other
- \$0.04 to Vacation & Holiday

Effective July 1, 2013, there will be an increase of \$0.05 to Other. (*See Important Notice dated June 30, 2011*)

STOCKER, SCRAPPER (employed by same contractor for 2000 hours, consecutively or cumulatively) (All Areas)

Effective January 1, 2009, there will be an increase of \$0.225 to Basic Hourly Rate **for Area 3 only**.

Effective July 1, 2009, there will be the following increases:

- \$0.50 to Health and Welfare
- \$0.30 to Pension (includes \$0.05 to Annuity)
- \$0.13 to Vacation (includes \$0.08 to Work Fee)

Effective August 1, 2009, there will be an increase of \$0.875 to Basic Hourly Rate

Effective January 1, 2010, there will be an increase of \$0.225 to Basic Hourly Rate **for Area 3 only**.

Effective July 1, 2010, there will be the following increases:

- \$0.50 to Health and Welfare
- \$0.35 to Pension (includes \$0.10 to Annuity)
- \$0.18 to Vacation (includes \$0.08 to Work Fee)

Effective August 1, 2010, there will be an increase of \$0.50 to Basic Hourly Rate and \$.425 to Pension

Effective January 1, 2011, there will be an increase of \$0.225 to Basic Hourly Rate **for Area 3 only**.

Effective July 1, 2011, the \$0.98 increase has been rescinded. (*See Important Notice dated June 30, 2011*)

Effective August 1, 2011, there will be the following increases (*See Important Notice dated June 30, 2011*):

- \$0.75 to Pension
- \$0.11 to Health & Welfare
- \$0.04 to Vacation & Holiday

STOCKER, SCRAPPER (All Areas)

Effective January 1, 2009, there will be an increase of \$0.225 to Basic Hourly Rate **for Area 3 only**.

Effective July 1, 2009, there will be the following increases:

\$0.50 to Health and Welfare

\$0.13 to Vacation (includes \$0.08 to Work Fee)

Effective August 1, 2009, there will be an increase of \$0.875 to Basic Hourly Rate

Effective January 1, 2010, there will be an increase of \$0.225 to Basic Hourly Rate **for Area 3 only**.

Effective July 1, 2010, there will be the following increases:

\$0.50 to Health and Welfare

\$0.18 to Vacation (includes \$0.08 to Work Fee)

Effective August 1, 2010, there will be an increase of \$0.50 to Basic Hourly Rate and \$.425 to Pension

Effective January 1, 2011, there will be an increase of \$0.225 to Basic Hourly Rate **for Area 3 only**.

Effective July 1, 2011, the \$0.63 increase has been rescinded. (*See Important Notice dated June 30, 2011*)

Effective August 1, 2011, there will be an increase of \$0.11 to Health & Welfare and \$0.04 to Vacation & Holiday. (*See Important Notice dated June 30, 2011*)

There will be no further increases applicable to this determination.

Issued 8/22/2008. Effective for projects advertised for bids on or after 9/1/2008 until superseded.
