



PREDETERMINED INCREASE FOR

TRAFFIC CONTROL/LANE CLOSURE (LABORER)

(NC-23-102-13-2013-2 and NC-23-102-13-2013-2A)

AND

PARKING AND HIGHWAY IMPROVEMENT PAINTER (LABORER)

(NC-23-102-13-2013-2B)

IN ALL LOCALITIES WITHIN ALAMEDA, ALPINE, AMADOR, BUTTE, CALAVERAS, COLUSA, CONTRA COSTA, DEL NORTE, EL DORADO, FRESNO, GLENN, HUMBOLDT, KINGS, LAKE, LASSEN, MADERA, MARIPOSA, MARIN, MENDOCINO, MERCED, MODOC, MONTEREY, NAPA, NEVADA, PLACER, PLUMAS, SACRAMENTO, SAN BENITO, SAN FRANCISCO, SAN JOAQUIN¹, SAN MATEO, SANTA CLARA, SANTA CRUZ, SHASTA, SIERRA, SISKIYOU, SOLANO, SONOMA, STANISLAUS, SUTTER, TEHAMA, TRINITY, TULARE, TUOLUMNE¹, YOLO¹, AND YUBA COUNTIES.

This predetermined increase for the above named craft applies only to the current determination for work being performed on public works projects with bid advertisement dates on or after **May 24, 2013**, until this determination is superseded by a new determination or a predetermined increase modification notice becomes effective.

When referencing our prevailing wage determinations, please note that if the prevailing wage rate determination which was in effect on the bid advertisement date of a project has a single asterisk (*) after the expiration date, the rate will be good for the life of the project. However, if a prevailing wage rate determination has double asterisks (**) after the expiration date, the rate must be updated on the following date to reflect the predetermined rate change(s).

TRAFFIC CONTROL/LANE CLOSURE (LABORER) – all classifications including Traffic Control Trainee - Except PARKING AND HWY IMPROVEMENT PAINTER (LABORER)

Determinations NC-23-102-13-2013-2 and NC-23-102-13-2013-2A are currently in effect and expires on June 30, 2013**.

Effective July 1, 2013, the predetermined increase of \$1.60 is allocated as follows: \$0.75 to Basic hourly Rate, \$0.10 to Health and Welfare, \$0.57 to Pension, \$0.15 to Vacation and Holiday, \$0.02 to training, and \$0.01 to wages and/or fringes.

Effective June 30, 2014, the predetermined increase of \$1.35 is allocated as follows: \$0.50 to Basic Hourly Rate; \$0.20 to Health & Welfare; \$0.63 to Pension; \$0.02 to Training.

There will be no further increases applicable to these determinations.

PARKING AND HIGHWAY IMPROVEMENT PAINTER (LABORER)

Determination NC-23-102-13-2013-2B is currently in effect and expires on June 30, 2013*.

There are no predetermined increases applicable to this determination.
