## MASTER LABOR AGREEMENT

[Term: October 1, 2016 through September 30, 2020]
The following provisions reflect the dlscussion between the Palntars and Allid Trades District Council No. 36, on behalf of Drywall Fnishers Lecal Union 1136 (hereafter referred to as the "Unlon"), and the Weatam Whall and Celling Controctoss Assadotlon. Ins, negotiating on behalf of its respective members (hereafter referred to as the "Assoclation"). The Union and the Association are partles to the 2016-2020 Southern Calfiomia Drywall Finishere Jolnt Master Labor Agreement (hereaftar reforred to ts the "Agreement") and hereby agree to the following provislons to amend the Agreement:

1. All terms and conditions of the current Agreement (2016-2020) shall be extended for a pertod of two (2) years, commencing October 1, 2020 through Soptember 30, 2022.
a. Article 28 (1) of the Agreement shall be amended to reflect the extended controct period referred to os the "2020-2022 Drywall Fintsher's two (2) year extenston" effective October 2, 2020 through September 30, 2022. All relevant dates shall be changed throughout the Agreement.

B. Holiday Pay: Overtime shall be paid at the rate of one and one-half (1.5) times the regular rate, except after eight (8) hours on Saturdays, Sundays and the following holidays, which shall be paid at the rate of double time excluding make up days. New Year's Day, Memorial Day, Fourth of July, Labor Day, Veteran's Day, Thanksgiving Day, Friday after Thanksgiving, the Day before Christmas, and Christmas Day.

When one of the holidays listed above falls on Sunday, same shall be observed on the following Monday. When one of the holidays listed above falls on Saturday, no extra day will be given, except that if New Years should fall on Saturday, the Friday preceding shall be considered a legal holiday.
