ARTICLE XVIII FREE ZONE

SECTION 1. A free zone shall be established within 40 air miles from Sacramento City Hall. Employees shall receive travel allowance based on Section 2. (See Map, page 36.)

(1) On jobs within a distance of 40-50 air miles from Sacramento City Hall, the employee shall receive a

\$22.00 per work day travel allowance.

(2) On jobs more than 50 air miles from Sacramento City Hall, the employee shall receive \$50.00 per day worked, and in addition thereto, each time an employee is sent or assigned to a job, removed from a job or his employment terminated, he shall be paid time in amount equal to the straight time rate not to exceed eight (8) hours in any work day, and transportation paid at the rate of twenty cents (\$.20) per mile.

SECTION 2. Sacramento City Hall shall be used as the dispatch point for all work obtained through the Hiring Hall of the Local Union.

SECTION 3. The Employer's vehicle transporting employees shall be driven by a competent driver. No employee shall accept transportation in an Employer's vehicle unless it is satisfactorily enclosed against the elements of weather. Vehicles shall be provided with seats or benches. Employees are expressly forbidden to ride in the beds of trucks that contain gasoline, solvents, pipe, fittings, equipment or materials.
