The predetermined increase of \$2.50 scheduled to take effect on September 1, 2024 for the above mentioned crafts/classifications has been reduced; the correct predetermined increase amount and allocation are listed below:

Effective September 1, 2024, there will be an increase of \$2.42 allocated as follows: \$2.22 to the Basic Hourly Rate, \$0.10 to Training and \$0.10 to Other payments.

With the exception of the above correction, all of the wage rates and other conditions found in the above referenced prevailing wage determinations remain unchanged.
