**NOTICE OF EXTENSION OF COMMENT PERIOD**

**Subject Matter of Regulations: Foreign Labor Contractor Registrations**

**TITLE 8, CALIFORNIA CODE OF REGULATIONS  
Sections 13850 et seq.**

NOTICE IS HEREBY GIVEN that the Labor Commissioner, Chief of the Division of Labor Standards Enforcement, Department of Industrial Relations, is extending the comment period regarding proposed modifications to the text of the proposed regulations and new documents added to the rulemaking file for new Subchapter 14 of existing Chapter 6 of Division 1, of Title 8, California Code of Regulations, Foreign Labor Contractor Registrations.

This Notice of Extension of Comment Period is being issued because the Notice of Modifications to Text of Proposed Regulations and New Documents Added to the Rulemaking File that was issued on June 21, 2018 contained a typographical error in the email address for submission of written comments. The 15-day comment period for that Notice closed on July 6, 2018.
