ACCIDENT INVESTIGATIONS:

On March 9, 2023, an accident occurred involving two temporary amusement rides known as the Cliff Hanger (C17207) and Tornado (C17209). Both rides are owned and operated by Christiansen Amusements. At the time of the accident, the rides were located at 739 W. Florida Avenue, Hemet, CA. Evidence collected by the Division and a video recording with audio provided by the injured patron's parent, indicates the two rides were assembled in close proximity to each other and made contact during operation. As a result of this contact, the parent of the children involved stated one child, a 16-year-old female, sustained a concussion and complained of hearing loss in the right ear, dizziness, and blurred vision. Another child, a 14-year-old female, sustained a concussion, blurry vision, dizziness, and three broken

metacarpals. Another child, a 10-year-old male, sustained a concussion, blurry vision, dizziness, and a lazy left eye. An 8-year-old child sustained a concussion, blurry vision, and dizziness. At the conclusion of the inspection, the Division issued requirements to address several deficiencies and safety hazards.

INSPECTIONS:

The following table lists the owner and operators of portable amusement rides in the State of California, the number of programed inspections conducted for each owner/operator, and the number of annual and temporary permits issued during the 2023 operating year.

After an inspection of a portable amusement ride that is found to comply with all applicable regulations, the Division issues an annual operating permit.

When a Division inspector observes a violation deemed non-critical to the safe operation of a portable amusement ride but requiring corrective action, the inspector issues a temporary operating permit that expires on an assigned date within 30 days after issuance. When an inspector identifies a violation deemed critical to the continued safe operation of a ride, the Division withholds a permit until the violation is corrected.

There is no statutory obligation for the Division to conduct re-inspections of temporary amusement rides. The Division is authorized to conduct a re-inspection anytime a ride is disassembled and reassembled. No re-inspections occurred in the 2023 calendar year.
