Construction of any structures or ancillary facilities on the project that does not meet this definition requires the payment of the general commercial prevailing wage rates.

Double (2x) the basic straight-time hourly rate is paid for all hours worked on Sundays and Holidays. For the second and third shifts, one and one-half (1½x) time rates for all overtime hours worked and all hours worked on Saturdays, Sundays and Holidays.

RECOGNIZED HOLIDAYS:

New Year's Day, Martin Luther King Jr. Birthday, President's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Day after Thanksgiving, Christmas Day, and the weekday before or after Christmas.
