I. Call to Order/Roll Call

- a. Chairperson Benjamin Rivera called the meeting to order at 9:00am by starting the Pledge of Allegiance.
- b. DAS Chief Adele Burnes conducted the roll call.

 - ii. Members Absent: Mark Burri, Tierney Harrison (CAL-JAC)

II. Review/Approve Previous Minutes

- a. All Members present approved the previous minutes from the 2nd Quarterly CAC Meeting in Glendale with no questions or comments.
- b. Treasurer's Report
 - i. Mike Rivers gave a detailed treasurer's report.
 - ii. In May, there was a payment of \$1500 to Miller Kaplan for bookkeeping and tax services. There was also a \$25,000 payment to Hyatt regency Sonoma for the venue of the CCA 2026.
 - iii. The balance at the end of May 2025 was \$29,606.18.
 - iv. Since June 2025, there were 3 deposits of CCA per capita tax dues payments totaling \$305.

- v. The first Diamond sponsor for CCA is the North Bay Building and Construction Trades Council with a \$5,000.
- vi. Additional conference sponsors include the San Joaquin County Building and Construction Trades Council and the San Mateo County Building and Construction Trades Council for a total of \$1500.
- vii. All Members present approved the Treasurer's Report.

III. 2026 California Conference on Apprenticeship – CCA

- a. Benjamin Rivera stated the California Conference on Apprenticeship (CCA) 2026 will be at the Hyatt Regency Sonoma Wine Country located at 170 Railroad Street, Santa Rosa, California, 95401. Charles M. Schulz Sonoma County Airport is the nearest airport.
