

## CALIFORNIA APPRENTICESHIP COUNCIL 2025 EQUAL OPPORTUNITY IN APPRENTICESHIP COMMITTEE MINUTES

## Wednesday, May 7, 2025 11:00 a.m.

## **Chairperson Sheri Learmonth**

- T. Call to Order/Roll Call
  - a. Chairperson Learmonth called the meeting to order at approximately 11:44am.
  - b. DAS Chief Adele Burnes conducted the roll call.
    - Members Present: Sheri Learmonth, Chip Martin, Earl Restine, Shelley i. Duran, Frank J. Quintero, Jason Rafter, Jack Buckhorn, Todd Braverman, and DAS Chief Adele Burnes.
    - ii. Members Absent: None
- Review/Approve Previous Minutes II.
  - a. Members approved the minutes from the previous meeting held on January 22, 2025.
- III. Presentation - Megan Nazareno, CTWI
  - Megan Nazareno, Deputy Director of the Construction Trades Workforce Initiative (CWTI), presented on CWTI's initiatives focused on women and youth participation in the construction trades.
  - b. She introduced two key CWTI initiatives:
    - Integrating the MC3 construction pre-apprenticeship curriculum in high schools and community colleges
      - 1. Established MC3 programs at 6 high schools and 1 community college
      - 2. Provided comprehensive services for school partners, including

- curriculum design, industry alignment, stakeholder education, and career placement support
- 3. Outcomes: Over 200 youth enrolled, 50% women, 68% racial minorities, 92% completion rate
- 4. Held an MC3 Professional Development Workshop to expand industry connections, strengthen peer connections, and enhance programming
- ii. Initiatives encouraging women's participation in construction
  - 1. Current implementation of a project under the ERECA grant, with 16 different partners
  - 2. Objectives: Provide childcare stipends and enhance outreach strategies
  - 3. Outcomes: Served 162 recipients, 36% women, \$1.4 million in stipends distributed
- iii. Looking ahead, CTWI wants to explore apprentice retention by stacking child care stipends with enhanced mentorship programming, and assess their pre-apprenticeship programs to ensure they are meeting quality standards and effectively placing students.
- c. Juan, Labor and Employment Specialist at CTWI, discussed the organization's role in career navigation support for MC3 program participants. He stated CTWI conducts one-on-one meetings to determine trade interests and provide resources and recommendations, with the goal to provide students with as much support as possible and ensure they feel prepared for post-graduation.
- d. Members expressed appreciation for CTWI's efforts, particularly the high representation of women in their programs, and interest in CTWI's potential collaboration with California Jobs First grant-funded programs.
