WHEREAS, on or about October 9, 2024, the Administrative Director mailed to Holly Dickson a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Holly Dickson that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Holly Dickson submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the notice; and
