WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification, or approval to provide health care services has been surrendered or revoked; and

WHEREAS, on or about July 7, 2023, Respondent Rebecca Jo Herron's, aka Rebecca Jo Sharp (Rebecca Herron) license, certification, or approval to provide health care services was surrendered or revoked by the Board of Vocational Nursing and Psychiatric Technicians, Department of Consumer Affairs; and

WHEREAS, on or about October 8, 2024, the Administrative Director mailed to Rebecca Herron a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Rebecca Herron that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Rebecca Herron submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the notice; and

8	IT IS HEREBY ORDERED that Respondent Rebecca Herron is hereby suspended
9	from participating in the workers' compensation system as a physician, practitioner, or
10	provider.
