WHEREAS, Labor Code section 139.21(a)(1)(C) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider whose license, certification, or approval to provide health care services has been surrendered or revoked; and

WHEREAS, on or about July 14, 2023, Respondent Jeannie Ann Horton's (Jeanne Horton) license, certification, or approval to provide health care services was surrendered or revoked by the Board of Registered Nursing, Department of Consumer Affairs; and

WHEREAS, on or about October 8, 2024, the Administrative Director mailed to Jeannie Horton a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Jeannie Horton that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Jeannie Horton submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the notice; and

WHEREAS, Jeannie Horton did not submit a written request for hearing within ten
(10) calendar days of the date of mailing of the notice; and
