ORDER OF SUSPENSION

WHEREAS, Labor Code section 139.21(a)(1)(A) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider if the individual has been convicted of any felony or misdemeanor described in Labor Code section 139.21(a)(1)(A); and

WHEREAS, on or about March 17, 2023, Respondent Oliver Haskel Jenkins (Oliver Jenkins) pled guilty to or was found guilty of one or more felonies or misdemeanors described in Labor Code section 139.21(a)(1)(A) in the Unites States District Court, Northern District of Ohio; and

WHEREAS, Labor Code section 139.21(a)(1)(B) requires the Administrative Director to suspend any physician, practitioner, or provider from participating in the workers' compensation system as a physician, practitioner, or provider who has been suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, Oliver Jenkins was suspended, due to fraud or abuse, from the federal Medicare or Medicaid programs; and

WHEREAS, on or about May 21, 2025, the Administrative Director mailed to Oliver Jenkins a written notice of the right to a hearing regarding the suspension and the

1 procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2)
2 and California Code of Regulations, title 8, section 9788.1; and

3 WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of
4 Regulations, title 8, section 9788.1(d), the written notice advised Oliver Jenkins that the
5 suspension would start thirty (30) calendar days after the date of mailing of written notice,
6 unless Oliver Jenkins submitted a written request for a hearing within ten (10) calendar
7 days of the date of mailing of the notice; and

8 WHEREAS, Oliver Jenkins did not submit a written request for hearing within ten
9 (10) calendar days of the date of mailing of the notice; and

10 WHEREAS, the Administrative Director is required to suspend any physician,
11 practitioner, or provider pursuant to Labor Code section 139.21 and California Code of
12 Regulations, title 8, section 9788.2, after thirty (30) days from the date the notice was
13 mailed, unless the physician, practitioner, or provider submits a written request for a
14 hearing within ten (10) calendar days of the date of mail of the notice;

15 **IT IS HEREBY ORDERED** that Respondent Oliver Jenkins is hereby suspended
16 from participating in the workers' compensation system as a physician, practitioner, or
17 provider.
