WHEREAS, on or about May 11, 2022, Respondent Mohammadreza A. Yazdi's license, certification, or approval to provide health care services was surrendered or revoked by the Dental Board, Department of Consumer Affairs; and

WHEREAS, on or about September 11, 2024, the Administrative Director mailed to Mohammadreza A. Yazdi a written notice of the right to a hearing regarding the suspension and the procedure to follow to request a hearing, as provided in Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1; and

WHEREAS, pursuant to Labor Code section 139.21(b)(2) and California Code of Regulations, title 8, section 9788.1(d), the written notice advised Mohammadreza A. Yazdi that the suspension would start thirty (30) calendar days after the date of mailing of written notice, unless Mohammadreza A. Yazdi submitted a written request for a hearing within ten (10) calendar days of the date of mailing of the notice; and

WHEREAS, Mohammadreza A. Yazdi did not submit a written request for hearing
within ten (10) calendar days of the date of mailing of the notice; and
