ACCIDENT INVESTIGATIONS:

On June 8, 2024, an accident occurred on a temporary amusement ride known as Eagle 16 Ferris Wheel (C20217), owned and operated by So Cal Rides. At the time of the accident, the ride was located at 2625 Vermont Ave. in Los Angeles, CA. As the ride cycle was ending and the operator was unloading passengers, the ride unexpectedly moved. As a result, the patrons who were in the process of unloading sustained injury. One minor female patron fell to the platform and sustained bruising and swelling on her face and was transported to a local hospital for evaluation. A male patron injured his shin and declined onsite first aid. As a result of the Division of Occupational Safety and Health (Division)'s investigation, requirements were issued to correct the owner/operator's operational, maintenance, and inspection procedures.

INSPECTIONS:

The following table lists the owners and operators of portable amusement rides in the State of California, the number of rides inspected for each owner/operator, and the number of annual and temporary permits issued during the 2024 operating year.

After an inspection of a portable amusement ride that is found to comply with all applicable regulations, and the receipt of all applicable fees, the Division issues an annual operating permit.

When a Division inspector observes a discrepancy deemed non-critical to the safe operation of a portable amusement ride that requires corrective action, the inspector issues a temporary operating permit that expires on an assigned date within 30 days after issuance.

No permit is issued when an inspector identifies a hazard deemed critical to the continued safe operation of a ride.
