Upon review of the 07/26/2022 Notice of Order of Suspension to Lee Mathis with the 09/12/2022 Order of Suspension, the 04/29/2024 Notice of Order of Suspension to Lee R. Mathis & Associates aka Mathis & Associates with the 07/02/2024 Order of Suspension, the 11/15/2022 Notice of Order of Suspension to Foremost Shockwave Solutions, Inc., with the 12/28/2022 Order of Suspension, the 08/06/2024 Notice of Order of Suspension to Advanced Medical Resources, Inc with the 11/12/2024 Order of Suspension, each issued by the Administrative Director and allegations therein; and, Each Order of Suspension setting forth conviction for felony or misdemeanor and that crime either: (1) involves fraud or abuse of the federal Medicare or Medicaid programs, the Medi-Cal program, or the workers' compensation system, or fraud or abuse of any patient; (2) relates to the conduct of the individual's medical practice as it pertains to patient care; or (3) is a financial crime that relates to the federal Medicare or Medicaid programs, the Medi-Cal program, or the workers' compensation system; and that, on or

about June 19, 2020, Respondent Lee Mathis (Mathis) was convicted in the United States District Court, Southern District of California, of crimes described in Labor Code section 139.21(a)(1)(A). (United States of America v. Mathis, Case No. 15- CR-2822-CAB.); and,

In review of the 07/01/2026 Petition by counsel for Farmers Insurance for consolidation Review of the list of Workers' Compensation case numbers tied to these providers; and, There being common issues of Law and Fact including:

- 1) Whether the automatic stay provision of Labor Code Section 139.21 applies to each of the Lien Claimants based on the conviction of Lee Mathis and the issuance of the Order of Suspension to each of the Lien Claimants.
- 2) Whether Lien Claimants are subject to Special Lien Proceedings pursuant to Labor Code Section 139.21(e)(2) based on the issuance of an Order of Suspension for all Lien Claimants by the Administrative Director .
- 3) Whether each and/or any of the liens of these lien claimants are to be dismissed based on the convictions set forth in the finding and orders set forth in case United States of America v. Mathis, Case No. 15- CR-2822-CAB.
- 4) Whether Lien Claimants have met their burden of proof so as to avoid dismissal of all liens pursuant to §139.21(g).

Good Cause Shown,

IT IS FOUND that:

There are common issues such that a consolidation is appropriate in this matter; and, Consolidation is appropriate in this matter.

There is good cause to determine whether there is a nexus between the violations upon which the convictions are based and the services set forth in the liens asserted in the attached lien list.

Therefore, pursuant to delegated authority from the Chief Judge of the Division of Workers' Compensation,

IT IS ORDERED that the liens set forth in cases identified in Attachment A, filed by or on behalf of suspended entities Lee Mathis, Lee Mathis & Associates aka Mathis & Associates, Foremost Shockwave Solutions, Inc., and Advanced Medical Resources,

Inc., are hereby **CONSOLIDATED** for adjudication and disposition in a special lien proceeding to determine the issues pertinent under Labor Code section 4615.

IT IS FURTHER ORDERED that all liens of Lee Mathis, Lee Mathis & Associates aka Mathis & Associates, Foremost Shockwave Solutions, Inc., and Advanced Medical Resources, Inc., are hereby **STAYED** pending further determination. If it is later determined that additional matters should be included in this consolidation an additional order shall issue.

IT IS FURTHER ORDERED that the subject of the determinations of the liens of Lee Mathis, Lee Mathis & Associates aka Mathis & Associates, Foremost Shockwave Solutions, Inc., and Advanced Medical Resources, Inc. are **bifurcated** from the all other issues in the cases-in-chief so as to not disrupt the determinations of the balance of the case and rights of the Applicant.

Judge Zoellner at the Long Beach District Office of the Workers' Compensation Appeals Board is designated as the assigned judge for purposes of this consolidation.

All documents regarding this consolidation shall be filed either by mail to the Long Beach district office, or by electronic filing by EAMS or JET. This case is set for status conference on September 2, 2026 at 10:30 a.m. before Judge Zoellner, 1500 Hughes Way, Ste C203, phone number: 1-562-590-5001.
