### ASBESTOS REMOVAL WORKER (LABORER) (NC-102-67-1-2010-1) ASBESTOS REMOVAL SPECIALIST I & II ASBESTOS REMOVAL WORKER

ALAMEDA, ALPINE, AMADOR, BUTTE, CALAVERAS, COLUSA, CONTRA COSTA, DEL NORTE, EL DORADO, FRESNO, GLENN, HUMBOLDT, KINGS, LAKE, LASSEN, MADERA, MARIN, MARIPOSA, MENDOCINO, MERCED, MODOC, MONTEREY, NAPA, NEVADA, PLACER, PLUMAS, SACRAMENTO, SAN BENITO, SAN FRANCISCO, SAN JOAQUIN, SAN MATEO, SANTA CLARA, SANTA CRUZ, SHASTA, SIERRA, SISKIYOU, SOLANO, SONOMA, STANISLAUS, SUTTER, TEHAMA, TRINITY, TULARE, TUOLUMNE, YOLO, AND YUBA COUNTIES

This predetermined increase for the above named craft applies only to the current determination for work being performed on public works projects with bid advertisement dates on or after **September 1, 2010**, until this determination is superseded by a new determination or a predetermined increase modification notice becomes effective.

When referencing our prevailing wage determinations, please note that if the prevailing wage rate determination which was in effect on the bid advertisement date of a project has a single asterisk (\*) after the expiration date, the rate will be good for the life of the project. However, if a prevailing wage rate determination has double asterisks (\*\*) after the expiration date, the rate must be updated on the following date to reflect the predetermined rate change(s).

#### **ASBESTOS REMOVAL WORKER (LABORER): ASBESTOS REMOVAL SPECIALIST I & II**

Determination NC-102-67-1-2010-1 is currently in effect and expires on November 30, 2010\*\*.

- **Effective December 1, 2010**, the \$0.75 increase is allocated as follows: \$0.65 to Vacation and Holiday and \$0.10 to Training.
- **Effective December 1, 2011**, the \$0.80 increase is allocated as follows: \$0.74 to Vacation & Holiday and \$0.06 to Training.
- **Effective December 1, 2012**, the \$0.90 increase is allocated as follows:  
**Asbestos Removal Specialist I:** \$0.43 to the Basic Hourly Rate, \$0.20 to Health & Welfare, and \$0.27 to Vacation/Holiday.  
**Asbestos Removal Specialist II:** \$0.24 to the Basic Hourly Rate, \$0.20 to Health & Welfare, and \$0.46 to Vacation/Holiday.

#### **ASBESTOS REMOVAL WORKER (LABORER): ASBESTOS REMOVAL WORKER**

Determination NC-102-67-1-2010-1 is currently in effect and expires on November 30, 2010\*\*.

- **Effective December 1, 2010**, the \$0.75 increase is allocated as follows: \$0.65 to Vacation and Holiday and \$0.10 to Training.
- **Effective December 1, 2011** the \$0.80 increase is allocated as follows: \$0.74 to Vacation & Holiday and \$0.06 to Training.
- **Effective December 1, 2012**, the \$0.85 increase is allocated as follows: \$0.38 to the Basic Hourly Rate, \$0.20 to Health & Welfare, and \$0.27 to Vacation/Holiday.

There will be no further increases applicable to this determination.
