**PREDETERMINED INCREASE FOR
DRYWALL INSTALLER/LATHER (CARPENTER)
(NC-31-X-16-2012-2)**

IN ALL LOCALITIES WITHIN ALAMEDA, ALPINE, AMADOR, BUTTE, CALAVERAS, COLUSA, CONTRA COSTA, DEL NORTE, EL DORADO, FRESNO, GLENN, HUMBOLDT, KINGS, LAKE, LASSEN, MADERA, MARIN, MARIPOSA, MENDOCINO, MERCED, MODOC, MONTEREY, NAPA, NEVADA, PLACER, PLUMAS, SACRAMENTO, SAN BENITO, SAN FRANCISCO, SAN JOAQUIN, SAN MATEO, SANTA CLARA, SANTA CRUZ, SHASTA, SIERRA, SISKIYOU, SOLANO, SONOMA, STANISLAUS, SUTTER, TEHAMA, TRINITY, TULARE, TUOLUMNE, YOLO & YUBA COUNTIES.

This predetermined increase for the above named craft applies only to the current determination for work being performed on public works projects with bid advertisement dates on or after **September 1, 2012**, until this determination is superseded by a new determination or a predetermined increase modification notice becomes effective.

When referencing our prevailing wage determinations, please note that if the prevailing wage rate determination, which was in effect on the bid advertisement date of a project, has a single asterisk (*) after the expiration date, the rate will be good for the life of the project. However, if a prevailing wage rate determination has double asterisks (**) after the expiration date, the rate must be updated on the following date to reflect the predetermined rate change(s).

DRYWALL INSTALLER/LATHER (CARPENTER) (All Areas):

Determination NC-31-X-16-2012-2 is currently in effect and expires on June 30, 2013**.

Effective July 1, 2013, there will be the following increases:

- \$0.65 to Health & Welfare
- \$0.05 to Training
- \$0.05 to Vacation & Holiday (Work Fee)
- \$0.05 to Other

Effective August 1, 2013, there will be the following increases:

- \$0.85 to Basic Hourly Rate
- \$0.15 to Pension

Effective July 1, 2014, there will be the following increases:

- \$0.50 to Health & Welfare
- \$0.35 to Pension
- \$0.05 to Vacation & Holiday (Work Fee)
- \$0.05 to Training

Effective August 1, 2014, there will be an increase of \$1.00 to Basic Hourly Rate.

STOCKER, SCRAPPER (employed by same contractor for 2000 hours, consecutively or cumulatively) (All Areas)

Effective July 1, 2013, there will be the following increases:

- \$0.65 to Health & Welfare

\$0.05 to Vacation & Holiday (Work Fee)
\$0.15 decrease to Pension

Effective August 1, 2013, there will be the following increases:
\$0.43 to Basic Hourly Rate
\$0.07 to Pension

Effective July 1, 2014, there will be the following increases:
\$0.50 to Health & Welfare
\$0.20 to Pension
\$0.05 to Vacation & Holiday (Work Fee)

Effective August 1, 2014, there will be an increase of \$0.50 to Basic Hourly Rate.

STOCKER, SCRAPPER (All Areas)

Effective July 1, 2013, there will be the following increases:
\$0.65 to Health & Welfare
\$0.05 to Vacation & Holiday (Work Fee)
\$0.15 decrease to Pension

Effective August 1, 2013, there will be the following increases:
\$0.43 to Basic Hourly Rate
\$0.07 to Pension

Effective July 1, 2014, there will be the following increases:
\$0.50 to Health & Welfare
\$0.10 to Pension
\$0.05 to Vacation & Holiday (Work Fee)

Effective August 1, 2014, there will be an increase of \$0.50 to Basic Hourly Rate.

There will be no further increases applicable to this determination.
