OPINION AND DECISION AFTER RECONSIDERATION

We granted reconsideration in this matter to further study the factual and legal issues presented. This is our Opinion and Decision After Reconsideration.

Defendant Technology Insurance Company petitions for reconsideration of the Findings and Orders issued by the workers' compensation administrative law judge (WCJ) in this matter on August 7, 2024. In that decision, the WCJ found, in pertinent part, that lien claimant Darrell Burstein, M.D. performed valid medical-legal services on or about June 2, 2020, and August 12, 2021, and awarded Dr. Burstein reimbursement for those services along with penalty and interest. Defendant contends that the WCJ erred in finding defendant liable for payment to lien claimant.

The WCJ filed a report recommending that the petition for reconsideration be denied.

Subsequently, at our request lien claimant and defendant participated in a commissioners' settlement conference and agreed to resolve this matter by stipulation

The Stipulation, which was filed on February 3, 2025, provides for the settlement of lien claimant's claim in consideration of the payment by defendant of \$2,300.00.

Therefore, we will (1) rescind the Findings and Orders issued by the WCJ in this matter on August 7, 2024, and (2) approve the Stipulation.

Finally, we commend the parties for engaging in good faith negotiations and successfully resolving this matter without the need for further litigation.

For the foregoing reasons,

IT IS ORDERED as the Decision After Reconsideration of the Workers' Compensation Appeals Board that the Findings and Orders issued by the workers' compensation administrative law judge in this matter on August 7, 2024, be **RESCINDED**.

IT IS FURTHER ORDERED that the Stipulation filed February 3, 2025 be APPROVED.
