### OPINION AND DECISION AFTER REMITTITUR

This Opinion and Decision After Remittitur is issued pursuant to the remittitur to the Workers' Compensation Appeals Board, filed on April 7, 2025, by the Fourth District Court of Appeal, Division 2 (Court), in which the Court certified that its decision of August 14, 2023, has become final. This further follows the remittitur issued by the Supreme Court of California, issued on April 2, 2025, indicating that its decision of February 20, 2025 is final.

The Supreme Court affirmed the decision of the Court of Appeal, which reversed the opinion of the Workers' Compensation Appeals Board and provided the parties with guidance as to what may constitute an award of damages under Labor Code section 4553.

Accordingly, as our Decision After Remittitur, we will rescind the Opinion and Decision After Reconsideration issued by the Appeals Board on April 13, 2022<sup>1</sup>, rescind the Findings of Fact issued by the workers' compensation administrative law judge on November 8, 2021, and return the matter to the trial level.

For the foregoing reasons,

**IT IS ORDERED** as the Decision After Remittitur of the Workers' Compensation Appeals Board that the Opinion and Decision After Reconsideration issued by the Appeals Board on April 13, 2022 is **RESCINDED**.

**IT IS FURTHER ORDRED** that the Findings of Fact issued on November 8, 2021, is **RESCINDED** and this matter is **RETURNED** to the trial level for further proceedings.
